Presentation Our Schools Now Initiative: this has been postponed due to scheduling conflicts (see C&A report below).

Chairman's report – Anthony; He reported that he had received an Email about free programs for students on free and reduced lunch. Marian was given a copy of the email.

Principal's report – Marian; Reported about the Health and Wellness Instruction in the classroom. She also reported that we are currently short staffed during lunch recess, but are working to provide supervision. This year's goal was met by hiring a dance instructor. This coming year's goal is to focus on providing healthy food choices at school/community events. Marian reported on some of the important achievements of Guy Nickerson in advanced Math instruction. She also reported on the application process for Blue Ribbon School recognition.

LAND Trust – Marian: our Land trust monies for next year have been divided into the following approximate amounts; 16,000 Art Instructor, 18,000 Para-pros, 11,000 math consumables. We approved the budget as listed above.

PTA - Jill; Flyers with information about the See's Spring Fundraiser went out today. The PTA dinner for the teachers during SEP's was provided by a mom's restaurant and was great. This coming week will include RIF and other activities for "Reading Is Fun" week. Thursday will be the Spaghetti Factory restaurant night fundraiser. The Chick-Fillet night raised \$300.

Staff – Beth; Please keep looking for Para-pros and specifically a Gym/PE teacher for next year.

Other - ; Marian reported that the wiring for the school security door system have been completed, and we are now waiting for the installation of the doors. There is concern about developing a script to be used to answer the door, and who will be responsible to monitor and answer the door. Kristie asked about the No-Parking sign on the North side of the building. Marian reported that it was not out today because the custodian was clearing walks. There was some discussion about having a "Wear Orange for Safety" day. Marian was interested in the idea and will look at the feasibility of scheduling one.
