Chair Report – Anthony; questioned about school lock down or lock out. We had not had one. There was a situation at Liberty Elem, but it did not affect Hawthorne.

Principal Report – Marian; She reported about having the Police presence, (Thank you to Office Tueller who is often here at our school) and how that has been reassuring to our students.

We will be participating in the Great Shake out on April 19<sup>th</sup>.

We are hoping to get training on use of the School Security system. There are areas of concern which staff have encountered which we need to address.

Reports:

C&A - Kristie; they had their Parent meeting where teachers were introduced to the parents and parent representatives were set up for each classroom. One of the parents is wanting to take on the task of working to help ease the transition between Elementary and Middle School. There has been a movement to request that the school look into electronic & social media communications.

ELP – Heather R.; It has been decided that there will not be an ELP-K at Emerson next year. This may affect our Kindergarten numbers. Our ELP Program would like to find a way to provide additional hours to the Spanish Teacher in an effort to retain her, possibly through offering an after-school class to the C&A and Neighborhood Programs.

Neighborhood – Marian; reported that the Substitute teacher in Room 1 for Patti Jachim is doing great – however Patti is not. Her recovery is taking longer than first anticipated, and she may not be back this year. We will be working to figure out how to take care of the end-of-year testing, and some kind of promotion/celebration for the students.

PTA - Ashley; the See's fundraiser went better than before and netted approximately \$2K for PTA. PTA Board is still in need of people who are willing to serve. The RIF during Reading is Fun Week was very successful, and greatly appreciated by the school.

Staff – Beth; School Faculty is asking that parents not be opening the Auditorium Doors during events. We want to emphasize safety. We are still looking for a PE teachers as well as some good Parapro's for next year.

Other – we are still having issues with drivers parking in the loading/unloading area of the driveway.
